VISA CHECKLIST

This is a list of both **BASIC** and **SPECIFIC** requirements (only for the most common types of visas). Please **CLICK ON HIPERLINKS** where applicable. If your requested visa is not listed, please visit the official visa website: <http://vistoperitalia.esteri.it/home/en>

**IMPORTANT**

1. Strictly each applicant need to **book an appointment [online](#)**.
2. Applications cannot be lodged earlier than 3 months before the starting date of the intended trip. **Appointments can be booked any time of the year.**
3. If **visiting other Non-Schengen** countries before or after a Schengen trip, applicants must make sure that all relevant visas are on passport **BEFORE** applying for a Schengen visa.
4. Applicants who are not residing in Australia and are currently visiting Australia for **tourism** or business **cannot apply for a Schengen visa from Australia**, they can only apply from their country of residence.
5. Submitting all the documents requested is no guarantee to obtain a Schengen Visa. The consular **officer may request further documents** to be produced as appropriate.
6. It is mandatory for all holders of a Schengen Visa to **return to Australia** at the end of the trip.
