



## Consolato d'Italia Brisbane

Visas are divided into several categories, depending on the duration and reason of stay, as follows:

- Schengen Visas (up to 90 days) "C Type" tourism, business, study, sport, mission, etc.
- National Visas (over 90 days) "D Type", employment, working holiday, study, elective residency, etc.

A Schengen Visa allows travel throughout the **26 countries** of the "Schengen Area" on a single visa. Apply for the visa at the Embassy, High Commission or Consulate of the Schengen country where you intend to stay the longest. If you will be staying an equal length of time in more than one Schengen country, apply for your visa at the embassy/consulate of the first Schengen country you will visit.

Visa requests must be lodged at the Consulate of Italy of the state where you legally reside. **The Consulate of Italy in Brisbane accepts visa applications lodged by residents of QLD and NT only.**

#### IMPORTANT

- **Each applicant must book an appointment [online](#)** and lodge their application in person.
- **Appointments can be booked anytime** but they are subject to availability (**appointments must be confirmed between 10 and 3 days prior to the appointment date**).
- In case you believe you need an earlier appointment please try checking the booking system for cancelled appointments.
- Applications **cannot be lodged earlier than 3 months before** the arrival in Italy/Schengen area.
- If visiting other Non-Schengen countries (so it's the United Kingdom for example) before or after a Schengen trip, applicants **must make sure that all relevant visas are on passport BEFORE** applying for a Schengen visa.
- Applicants who are not residing in Australia, but are currently **visiting Australia for a short period**, can only **apply in their country of residence**.
- Submitting all listed documents does not guarantee the issuing of the visa. The consular **officer may request further documents** as appropriate and the application will not be processed until the Consulate receives the requested documents.
- It is mandatory for all holders of a Schengen Visa to **return to Australia** at the end of the trip.
- **Minor age applicants need both parents consent.**

<b>ELECTIVE RESIDENCY SPECIFIC REQUIREMENTS</b>		
1	<b>Proof of solid economic position</b> to allow the applicant a one year long stay in Italy without need to work. Applicants must demonstrate a stable and adequate income stream (proof that it will be paid while overseas), such as Annuity, Superannuation, Rent and financial investments (statement from your accountant). Such economic activities must exclude <b>subordinate work</b> . <b>All documents must be shown in English ONLY</b> and in the applicant's name as shown on passport.	<input type="checkbox"/>
2	The bearer of an Elective Residency visa is <b>NOT ALLOWED to work within Europe and this is not an extended tourist visa</b> . This is a visa for people who legitimately wish to live in Italy and do not need to work while overseas. Please note that if such a requirement is deemed not to be satisfactory, a refusal may be issued.	
3	<b>Proof of available lodging</b> – contract of purchase or leasing agreement duly registered at the Italian Taxation Office (Agenzia delle Entrate) for the full year. Any proof of lodging needs to be under the applicant's name (as shown on passport). Please note that ownership of a <u>yacht</u> or other type of <u>boats</u> does not fulfill the requirement of lodging.	<input type="checkbox"/>
